### **What data do we collect?**

- Voluntarily complete a customer survey or provide feedback
- Use or view our website via your browser's cookies.

### **How will we use your data?**

Skips R Us collects your data so that we can:

- Process your order and manage your account.
- Email you with special offers on other products and services we think you might like.

When Skips R Us processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

## **Marketing**

Skips R Us would like to send you information about products and services of ours that we think you might like.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop Skips R Us from contacting you for marketing purposes or giving your data to other members of the Skips R Us Group.

## **What are your data protection rights?**

Skips R Us would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

**The right to access** – You have the right to request Skips R Us for copies of your personal data.

**The right to rectification** – You have the right to request that Skips R Us correct any information you believe is inaccurate. You also have the right to request Skips R Us to complete the information you believe is incomplete.

**The right to erasure** – You have the right to request that Skips R Us erase your personal data, under certain conditions.

**The right to restrict processing** – You have the right to request that Skips R Us restrict the processing of your personal data, under certain conditions.

**The right to object to processing** – You have the right to object to Skips R Us' processing of your personal data, under certain conditions.

**The right to data portability** – You have the right to request that Skips R Us transfer the data that we have collected to another organization, or directly to you, under certain conditions.

## **How do we use cookies?**

## **What types of cookies do we use?**

There are a number of different types of cookies, however, our website uses:

- **Functionality** – Skips R Us uses these cookies so that we recognize you on our website and remember your previously selected preferences. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.
- **Advertising** – Skips R Us uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and your IP address. Skips R Us sometimes shares some limited aspects of this data with third parties for advertising purposes. We may also share online data collected through cookies with our advertising partners. This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.

## **How to manage cookies**

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.
